PROPOPSTA TECHNICAL ASSISTANCE AND WARRANTY

1) METHOD OF ASSISTANCE OF CALLS IN THE GUARANTEE PERIOD

During the warranty period calculated in 24 months, in case of breakdowns or problems due to equipment malfunctions, the Company undertakes to act as follows:

2) TOTAL WARRANTY EQUIPMENT COVERAGE AND TECHNICAL ASSISTANCE MANAGEMENT

- 1. The EV.SERVICE ITALIA. warrants for 24 MONTHS (24) from the date of testing, repair or replacement, of the Products covered by this warranty (see above) or part of the Products manufactured and / or marketed that have manufacturing defects and / or materials that they comprise them, at no charge to the buyer except for those due to taxes of products or part of products, and in case of export products outside the European community the transport costs are borne by the purchaser.
- 2. This Warranty is valid and recognized on condition that:
- to. the Purchaser sends to the EV.SERVICE ITALIA. the relative "Certificate of Guarantee for each product or complete system" duly completed within 24 HOURS from delivery;
- b. the Purchaser gives news to the EV.SERVICE ITALIA. of the discovery of defects within the warranty period;
- 3. The Purchaser shall keep the defective products or parts waiting for them to be checked by the EVSERVICE ITALIA representatives, or the latter will instruct the Purchaser to send them to any of the locations indicated by EV. SERVICE ITALIA WITH ORIGINAL PACKAGING. The goods sent without the original packaging during the warranty period will void the warranty and will be charged for repair costs, in any case the Buyer can not return the Products or the defective parts to the EV.SERVICE ITALIA without having been previously authorized in this sense. Buyer agrees to ensure that those in charge of EV.SERVICE ITALY have free access to products covered by this warranty, the local and / or machines where these are located in order to meet obligations under this warranty; any expenses or costs arising from the acts for which the Purchaser prevents representatives from EV.SERVICE ITALY to fulfill the obligations of this Warranty will be borne by the Buyer, if the object of the guarantee products are found outside the Italian territory travel expenses will be paid by the buyer will be charged for the travel expenses and accommodation, while hours of work and the spare parts will be borne EV.SERVICE ITALY SRL. In the latter case, following authorization by the EVSERVICE ITALIA SRL, a local certified area technician can intervene for repairs in order to carry out repairs. Spare parts will be sent for free if covered by the warranty.
- 4.Buyer agrees to ensure that those in charge of EV.SERVICE ITALY have free access to products covered by this warranty, the local and / or machines where these are located in order to meet obligations under this warranty; any expenses or costs arising from the acts for which the Purchaser prevents representatives from EV.SERVICE ITALY to fulfill the obligations of this Warranty will be borne by the Buyer, if the object of the guarantee products are found outside the Italian territory travel expenses will be paid by the buyer will be charged for the travel expenses and accommodation, while hours of work and the spare parts will be borne EV.SERVICE ITALY SRL. In the latter case, following authorization by the EVSERVICE ITALIA SRL, a local certified area technician can intervene for repairs in order to carry out repairs. Spare parts will be sent for free if covered by the warranty.

- 5. EV.SERVICE ITALIA reserves the right to examine the returned material, to verify, at its sole discretion, their actual defects; in the event that the parts declared defective (and already previously replaced) are recognized by the EV.SERVICE ITALIA "immune to manufacturing defects or defects" complained by the Purchaser, EV.SERVICE ITALIA will send the Purchaser a regular invoice of the materials or works already provided.
- 6. Repairs and / or replacement of spare parts, during the warranty period, do not extend the duration of the same period for all the equipment; EV.SERVICE ITALIA will only guarantee for all those parts replaced the Warranty of EIGHTEEN months (18) from the date of installation. All Software and Hardware updates will be made during the warranty period (for updates we mean all the improvements that may affect the correct functioning of the system) any request outside of normal operation will be quoted separately. The EV.SERVICE ITALIA will decide autonomously if updates can be performed or they can not solve any emerging problems.
- 7. The obligations assumed by EV.SERVICE ITALIA with this warranty can not be extended by virtue of any interpretation and exclude any other claim for compensation against the EVSERVICE ITALIA Group companies. The recognition by EV.SERVICE ITALIA of the Guarantee does not give the right to request for direct, indirect or consequential damages, and furthermore:
- to. any EVSERVICE ITALIA Warranty is excluded for malfunctions that may occur due to incorrect installation of EVSERVICE ITALIA products or parts of them by the Purchaser;
- b. any warranty on the process and performance of the EQUIPMENT beyond its normal operation and its characteristics is excluded;
- c. any guarantee of EVSERVICE ITALIA is excluded in relation to defects or difficulties of use, even partial, deriving from improper, imprudent, negligent use or lack of proper expertise on the part of the Purchaser, his employees or persons authorized by them or by abrasion, alteration, corrosion, accident, or the use of equipment, plants or parts other than those indicated by EV.SERVICE ITALIA .;
- d. Any EVSERVICE ITALIA Warranty is excluded if a different use is made of the products specified in the purchase contract or in their technical descriptions as well as if the Purchaser does not follow exactly the instructions and the way of use communicated by the EV .SERVICE ITALIA
- is. Any guarantee of EVSERVICE ITALIA is excluded if the use of cleaning materials or similar causes malfunctions of the products supplied by EV.SERVICE ITALIA
- f. Ordinary consumer products such as funnel, beakers, paper rolls, catheters, peristaltic pump kits, electrode infusion bags, modules or electrical components of common use are excluded from the warranty (eg power supplies, etc.);
- g. The electrical / electronic parts of EVSERVICE ITALIA products damaged by improper use of the equipment by the Purchaser's personnel, or due to the inconstancy of supplying the mains electricity to the production site, the Purchaser are excluded from the Guarantee
- h. All costs incurred by EV.SERVICE ITALIA are excluded from the Guarantee in order to verify the quality and characteristics of the delivered products that must be borne by the Buyer if the defects of the Products or the difficulties of use are not attributable to objective responsibilities of EV.SERVICE ITALIA;

the. Abnormalities and / or malfunctions are also excluded from the warranty, even from mechanical, hydraulic, electrical or electronic components that derive from any modification to mechanical / electrical / electronic parts not carried out and / or authorized by EV.SERVICE ITALIA and with non-original parts.

Although not specifically mentioned above, the General Conditions of Sale will be authentic and, if the order is placed, will be enclosed with the Order Confirmation printed following the order.

This warranty can not be modified or revised or transferred to third parties in the event penalties are imposed according to the laws in force
